Sales Tax, Buyer's Premium & Other Buyer Expenses: The Auction Company is required to collect 6% Idaho sales tax from all buyers (unless otherwise exempt). The Auction Company will collect and remit all sales tax with no cost or benefit to the Seller. In addition, Buyer's Premium is a fee added to the high winning bid amount paid by the Buyer. This fee will be collected and retained by the Auction Company as no cost benefit to the Seller. Buyers who require items to be shipped to their location will be billed for any related expenses with no cost benefit to the Seller.

Settlement & Payment: The Auction Company will provide the Seller (or designated entity or representative) with the settlement statement and auction proceeds within 30 days of the sale of the items at auction. It is agreed that all auction fees and expenses will be deducted from the proceeds before satisfaction of liens or encumbrances and receipt of payment. Commissions will be calculated based on the gross selling price without the deduction of any liens or encumbrances.

Withdrawal or Cancellation: The Seller agrees that item(s) placed in the auction may not, for any reason, be removed by the Seller after this Agreement has been signed, without the signed written consent of the Auction Company. The Seller Shall not attempt to sell or dispose of any item(s) by any other means during the period of this Agreement. A breach of this paragraph shall be grounds for the Auction House to impose a reasonable penalty fee that reflects actual expenses incurred on behalf of the Seller (direct or indirect), court order, bankruptcy, etc., the Seller will be responsible for reimbursing the Auction Company for any/all expenses incurred on the Sellers behalf.

Indemnify: Seller agrees to indemnify and hold harmless the Auction Company and any employees, licenses, agents, successors or assigns, against any and all claims, injury, loss liabilities, lawsuits, damages, demands, action or cause of action whatsoever in any manner arising from this auction or privately negotiated sale, weather arising before, during or after the auction, including any accident or casualty occurring during transportation or storage of the items. This includes events related to hazardous materials, substances, sites and/or conditions, known or unknown.

Entire Agreement: This written Agreement constitutes the entire Agreement between the parties and no modification of this Agreement shall be effective unless made in writing and signed by the parties. Seller acknowledges receipt of a copy of this Agreement and attachments (if any). This agreement may be executed in one or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.

The Parties agree that the exclusive course of action in any litigation or dispute concerning the enforcement of this Agreement shall be submitted to the exclusive jurisdiction of the courts in the County of Twin Falls, State of Idaho, and the Idaho law shall govern. The Parties agree that this Agreement shall be binding on their heirs, personal representatives, successors and/or assigns. Seller and the Auction Company agree that they have had the opportunity to review this Agreement and have had an opportunity to be advised as to its contents, requirements, and liabilities, and have signed this Agreement fully understanding their respective rights, responsibilities and obligations as set forth herein.
